During the family visit by JJVS team members, anganwadi teachers, Miss Sharila Kujur and her assistant Miss Sanjalina Kujur discussed the status of the anganwadi school. Inputs on the health were given for the children between the age 0 to 6, 6 to 14 and 14 to 18. The anganwadi teacher stated that the children are hearty and healthy, free from any sickness.

Information was given by the anganwadi teacher about Parvati Bai, age 17, Holika Bai, age 18 and Anuradha Bai, age 22, had gone to Delhi for work and have returned. The JJVS team after being informed of their return, went out to meet their family members, where they found out that these girls were ready to venture once again to Delhi for work. When asked by the JJVS team about when the girls were leaving for DELHI, they said that they were leaving on 11.09.17. Later, the requested the girls to them along for work to Delhi, to which, the girls agreed. JJVS team their mobile numbers and came back to the organization quarters. Thereafter the team discussed the matter with the origization members. Miss Mamta Kujur gave the JJVS team initial steps to be taken.

On the day previously decided to leave for Delhi, Parvati Bai informed the team that her grandmother's health was not keeping well, so they could not leave as planned. The date had been postponed to 12.09.2017. On 12.09.2017, the plan was cancelled, once again, due to unknown reasons. The team continued to be in touch with them throughout the week. During these days Parvati Bai shared the mobile number of her aunt Gayatri Bai with Madhurima of the JJVS team. The team now tried to get into contact with Gayatri Bai.

Projecting themselves as prospective candidates to seek work in Delhi, the JJVS team contacted Gayatri Bai. The JJVS team told Gayatri Bai that they had told their parents about going for work to Delhi, after which, Gayatri Bai agreed to take the team Delhi for work. According to Gayatri Bai's plan, she would come on 21.09.2017, to pick up the girls from Jashpur and would leave for Delhi. The girls who were going to Delhi were:-

The team was not informed about him. When the team met Sahibul Mir, Gayatri told the team that he was her brother. Malti Tirkey, woman organization leader, Rakesh Ekka, Coordinator, UNICEFF child protection line manager and Jaspur police had watch over the movement of the team. The team was in touch and passing all the information of their movement through phone call and sms. At around 3:15pm the group boarded the bus to Ranchi.

Before the arrival of the train, the police, along with Child protection line and JJVS, arrested the group. The group was caught cheating on the reasons for their visit to Delhi. The arrested were taken back to Jashpur police station. The girls were kept in open custody and the boys were in the lockup throughout the night. Next day morning around 11.00 am councelling of the whole group was done. The group was presented before the C.W.C. After all that information had been collected, they found that Parvati Bai was a minor. So they kept her in the Vasundhara open custody and Holika Bai was kept in the Van stop centre. And the agent Gayatri kumari and Sahibul Mir were taken to Jaspur police station and FIR was filed against them.
